

## Dear Investigator,

Dear Study Coordinator,

In view of the holiday period at the end of the year, BARC would like to inform you of the shipping limitations and the critical items to be checked before planning your patient visits.

For Russia and Ukraine: Where possible, please avoid scheduling patients from December 19<sup>th</sup> till January 10<sup>th</sup>.

If patient visits during holiday period cannot be avoided, the shipment possibilities during this period depend on:

# BARC closure days<sup>(1)</sup>

Depending on your site location (24hr or 48hr sites<sup>(2)</sup>) no shipments can be performed 1 or 2 days before the closure days of the BARC affiliate you are shipping samples to.

#### Local public holidays

Do not ship samples on the day before local public holidays or on local public holidays. If agreed otherwise for your trial, please check the possibilities upfront with the premium courier.

## Courier service schedule / customs (only applicable if pro forma invoices are required)

As all couriers (standard as well as premium) may have restrictions, please contact them well in advance to check the following:

- The possible shipping days and custom closing times (if applicable)
- Possible earlier last calling / pickup times

## Type of shipment

Ambient shipments	Allowed if the above conditions are met.
Combined shipments – only for Russia and Ukraine**	Ambient samples should be shipped to BARC (provided the above conditions are met) & frozen samples are to be stored on site*.
Frozen shipments – only	Not allowed during this period – frozen samples are to be stored on
for Russia and	site*.
Ukraine**	Frozen batch shipments will not be organized by BARC.
3 <sup>rd</sup> party shipments	Contact BARC project management team upfront.

\* if not possible – please contact the BARC project management team

\*\* All other countries – besides Russia and Ukraine – no limitations for combined and frozen shipments – if the above mentioned conditions are met.

BARC will be providing continuous service during this time period (except on the closure days), so please contact us via the study specific email address or via the general contact details<sup>(3)</sup> in case of any doubts.
